The Board of Governors is the senior governing body of the University and is responsible for establishing the legal and administrative framework for the University. It has superintending and reforming power over all decisions affecting activities held at the University or connected with the University. It is composed of 25 voting members and one non-voting observer, the breakdown of which is outlined in article 25 of the By-Laws. Its general powers are set out in the University Charter while its specific functions and powers are listed under article 41 of the By-Laws.

Chair of the Board

Duties

The Chair of the Board of Governors chairs all meetings of the Board and of the Corporation. They are an Officer of the University and an ex-officio member of the Board of Governors, the majority of its standing committees as well as the Corporation.

Co-Chancellor

Duties

The Chancellor is the titular head of the University and serves as an ambassador to the University. The Chancellor presides at convocations and similar ceremonies and performs such official duties as the Board of Governors may designate. In accordance with the By-Laws, the Chancellor is a non-voting observer on the Board of Governors and an Officer of the University.

On July 1, 2020, Ms. Helen Antoniou began her first one-year term as Chair of Board of Governors. Ms. Antoniou was appointed to the Board on July 1, 2015 and served as Board Vice-Chair from July 1, 2019 to June 30, 2020.

Helen Antoniou is an executive coach for corporate leaders and their teams, as well as family business owners and their successors. She is the author of the Globe and Mail bestseller, Back to Beer... and Hockey: The Story of Eric Molson, a business biography of her father-in-law and past chairman of Molson Coors Beverage Company. Catherine Loubier, former delegate general of Quebec in New York, says she's excited to add her expertise to Concordia's Board of Governors over the next few years. At its June 18 meeting, the university's governing body welcomed Loubier as a new Board member.

Her wealth of government and private-sector knowledge will certainly be an asset for the Board. Among other roles, Loubier served as the province's highest-ranking representative in the United States from 2019 to 2021, deputy chief of staff to Quebec Premier François Legault from 2018 to 2019 and senior adviser to then Prime Minister of Canada Stephen Harper from 2013 to 2015.

Loubier's signature achievement as delegate general was leading the way for the record deal between Hydro-Québec and the State of New York, approved in 2022. At a value of \$20 billion US, it was Hydro-Québec's largest-ever export contract and helped promote the use of clean hydroelectric power.

As delegate general, she also met Concordia President Graham Carr and other university representatives and alumni on several occasions in New York City.

Loubier's business-world background includes being global director of communications for the Renault-Nissan-Mitsubishi Alliance, based in Paris. She holds a certificate in finance from Harvard Business School and a BA and MA in political science from the Université du Québec à Montréal.

The Montreal native is now based in Los Angeles and acts as an advisor to the business community on public policy and governance and sits on several boards.

'I see universities as strategic national assets, part of our heritage and culture'

What interested you about joining Concordia's Board of Governors?

Catherine Loubier: I am thrilled to join the Board of Governors to support the university's objectives in the years ahead. I came to appreciate the university fully when I served as top diplomat for Quebec in the United States. I believe I can provide advice on efficient and action-oriented approaches to government affairs, policy-making and stakeholder relations.

I met Graham Carr and we collaborated on Concordia's activities in New York. I also met several Concordia graduates, and I was quite impressed with their resolve, quality of education and successful ventures.

Concordia deserves to be much better known as a dynamic citizen of the province.

What do you see as Concordia's role among Quebec universities, as well as internationally?

CL: I see universities as strategic national assets, part of our heritage and culture. Concordia is a source of knowledge and innovation that attracts international talent with the potential to live and work in Quebec after they graduate — impressively, more than 50 per cent of international students who studied at Concordia have settled in Quebec, well above the Canadian average of around 30 per cent.

Nearly 20 per cent of international students enrolled at Concordia come from the French-speaking world. Those who don't speak it can learn French, with Concordia's support, and integrate into Quebec society.

With more than 17 per cent of students who speak French and more than 35 per cent who use other languages, Concordia is diverse. It contributes to Quebec's reputation at home and abroad, where many graduates shine in different fields beyond our borders.

Concordia will turn 50 in 2024 and I am honoured to be part of the Board of Governors for that milestone. I am convinced that as a next-generation university Concordia is well positioned to deliver a bright, diverse and engaged future for higher education.

You helped spearhead the historic Hydro-Québec and New York State deal signed in 2022. How do you see that influencing the future use of clean hydroelectricity, especially in the United States?

CL: To my knowledge, this is the largest renewable energy deal ever made in North America, and it is the largest cross-border deal of its type. That certainly sends a message throughout our continent that transition to cleaner energy is possible. This new transmission cable from Quebec to New York City will run for 545 kilometres, with 60 per cent underwater and 40 per cent underground. This is an example of ingenuity and of how to deliver clean energy with resiliency and environmental safety.

After it becomes fully operational in the spring of 2026, it will quickly displace fossil fuel with clean, reliable "always-on" hydro power from Quebec. The project will play a key role in New York State's energy transition and will help lower greenhouse-gas emissions — the equivalent of removing approximately 44 per cent of the cars from New York City streets.

What can you share about your experiences in the higher echelons of the Canadian and Quebec governments?

CL: These experiences have brought me so many things, but I will single out the power of consensus because of its importance on any board, and because women excel at it. Reaching consensus around a board table, a cabinet table, in a province, in a federation like Canada or at the multilateral level such as the G20 meeting is complex. It requires hard work and strategic thinking.

In addition to Indigenous law, he practices in the areas of business law and governance law. He has orchestrated important negotiations involving hydroelectric, mining, wind and forest developments. In 2002, he participated in the negotiations that led to the La Paix des Braves Agreement where he managed the hydroelectric component.

He has also worked with various international agencies such as the World Bank and the Inter-American Development Bank as well as other indigenous peoples in Russia and Panama.

In addition to practicing law, he is an artist who stands out for his huge portraits and murals. His most recent works can be admired in the conference room of the Montreal office as well as in the Indigenous Peoples Room at the Senate of Canada in Ottawa. As an airplane pilot, he is in a position to meet his customers and partners throughout Northern Quebec.

Cathy Wong is a municipal politician in Montreal, Quebec, Canada. She served on Montreal City Council as councillor for the Peter-McGill district from 2017 until 2021 and was the speaker of Montreal City Council. At 30 years old on her election, she was the first person of Chinese descent to serve at City Hall as the council's first female speaker. She was also the first opposition party member to sit in the chair. She replaced Frantz Benjamin, the first black speaker of the council.

As part of her role, Wong is mandated to raise citizens' access to city hall and municipal democracy, especially for women, youth, ethnic minorities, new residents, and Indigenous people, key targets in mayor Valérie Plante's election campaign. A Montreal diversity and inclusion advisory panel was a move by mayor Plante, with a one-year deadline to recommend necessary changes at city hall and related bodies.

Also under Wong's presidency, Montreal planned to rescind a historical but uncodified regulation which required male councilors to wear ties at council meetings. A city council commission supervising procedural rules and conduct, which she leads, decided to drop the rule to modernize City Hall.

As a member of the City of Montreal's Executive Committee, she oversaw diversity, employment inclusion, the French language, and the fight against racism and discrimination.

Wong was a member of the Équipe Denis Coderre party (before its post-election reconstitution as Ensemble Montréal) in the municipal elections of November 2017. On October 2, 2019, she joined the governing Projet Montréal party, citing its social values.

Wong did not run for reelection in 2021.

In November 2021, Wong was hired as Vice President of Equity, Diversity & Inclusion and Official Languages at Telefilm Canada.

Zaarour then landed a dream job at Air Canada, working in the corporate strategy department, growing Air Canada's international presence through alliances and partnerships. Her next move

was to Brazil for a senior advisor role in aviation-related investments at a private equity, before working as vice-president of business transformation at Aerolineas Argentinas.

In 2011, CBC/Radio-Canada recruited Zaarour to serve as the network's vice-president of people and culture, leading the human resources and labour relations components of the corporation during a major restructuring phase while building a five-year strategic plan to adapt to an evolving digital sphere. She stayed until 2015, taking a year off from work following the birth of her daughter.

Now, leading a team that enables business growth and the expansion of products and accounts, Zaarour has found her path balancing that business drive with a nurturing mindset she loves.

Dr. Stathopoulos obtained his Civil Engineering Diploma from the National Technical University of Athens, Greece, and obtained his M.E.Sc. and Ph.D. from the University of Western Ontario (1979). He has been awarded with two Honorary Doctorates in 2011 by Aristotle University of Thessaloniki (Greece) and in 2015 by Eindhoven University of Technology (The Netherlands).

In 1979, he joined the Centre for Building Studies at Concordia University. His work in the area of wind engineering and building aerodynamics has received national and international recognition. He was promoted to the rank of Associate Professor in 1982 and the rank of Professor in 1987. He has been Associate Director of the Centre for Building Studies for the years 1983 to 1995. In 1993, he was appointed Associate Dean of the Faculty of Engineering and Computer Science, a position he held until 1998 when he became Director of the Centre for Building Studies for the years 1998-2001. He was Associate Dean of the School of Graduate Studies at Concordia University from 2003 to 2010.

Dr. Stathopoulos has established an excellent teaching record at both the undergraduate and graduate levels and has also been active in the development of educational models. He has also received several awards for providing excellent teaching services, including the Concordia Council on Student Life Teaching Excellence Award in 1997, the Alumni Award for Excellence in Teaching in 2006, the ENCS Teaching Excellence Award in 2011, the President's Excellence in

Teaching Award in 2012, the Honoris Genius for Engineering Research / Education Award by the Ordre des Ingenieurs du Québec in 2020. In parallel, he has an outstanding research record with more than 600 publications in refereed journals and conference proceedings. His work in the area of wind engineering and building aerodynamics has received national and international recognition. It forms the basis for wind design of low-rise buildings in 1980, 1985, 1990, 1995, 2005, 2010, 2015, and 2020 National Building Code of Canada. Furthermore, it has been partly included in the 1982 American National Wind Standard (later ASCE 7-88, 93, 95, 98, 02, 05, 10, 16, and 22) and in other building design codes and standards.

He has been a consultant on numerous projects on issues related to wind-building interaction. He has acted as an expert witness on cases related to wind-building interaction. FINANCES

Throughout the year, the Board was kept apprised of the University's evolving financial situation via reports provided by the Finance Committee, the Chief Financial Officer as well as the President.

During the COVID-19 period, the University invested \$37.5 million to meet the demands of change and adjustment. For the period 2019-20 to 2021-22, the University experienced a cumulative loss of \$35.4 million in the operating fund, based on audited financial statements.

Concordia has experienced continuous growth over the last two decades, with an average rise in the student population of 1.6% between 2013 and 2021. This continuous growth supported development and investments, giving the University the capacity to present a balanced budget for the 2019-20 fiscal year.

However, 2021-22 and 2022-23 altered this trend as the total student population across Canada failed to grow for the first time in years and the entire Quebec university network experienced a decline in students. At Concordia, that decline was 2.4% in 2021-22 and 2.1% in 2022-23.

As a result of these demographic realities, Concordia's student population has been re-distributed. While out-of-province students increased in number by 9.1% and international students by 8.9%, a combined uptick of 929 students, the number of Quebec students dropped by 1,576 in 2022-23, a 7.4% decline. Quebec students represent 69% of the university's student population in 2022-23, while international students make up 22% and students from the rest of Canada total 9%.

Taking stock of the major trends and factors that affect the higher education sector, the University team forecasts a reduction in student population in the years to come, with three important factors influencing the student population evolution: demographics, the labour market and post COVID-19 confinement impacts.

Given these challenges, and the fact that structural changes take time, the University continues to be on a pragmatic path of deficit reduction. The 2023-24 integrated operating, capital and cash budget was adopted to continue on this path through a combination of prudent management of expenses and additional growth and diversification of revenues.
