Our Mandate

The CSU Legal Information Clinic is a free service that provides legal information, referrals to lawyers, and accompaniment in both French and English to undergraduate and since Fall 2021, graduate students at Concordia University. The LIC offers information related to issues on immigration, discrimination, small claims, human rights, contracts, and any other areas of law.

The LIC's mandate of access to justice also includes community outreach or collaborative projects with community organizations or other CSU departments such as CSU's Advocacy Centre and CSU's Housing and Job's Office (HOJO).



Our Unique Approach

- At the LIC, our goal is to not just provide you with legal information but instead, to empower you to make legal decisions that you feel confident about. Our staff is continuously trained in different fields of law but also in mental health care.
- With the assistance of supervising lawyers and law student volunteers, we initially meet and help clients organize their documents and the facts pertaining to their situation, to understand their needs and issues.
- The LIC carefully explains and educates students through legal information, research and examples on all their possible options so that they can come to a fully informed decision themselves on which choices are best for them, especially since they are the ones who will assume the consequences of their decisions.



Our Unique Approach

- The clinic spends at least 2-8 hours for simpler cases and many more hours for complex cases, applying a survivor-centred, trauma informed approach, especially for cases involving sexual violence, those discrimination and trauma.
- The clinic is an integral part of the ecosystem of CSU services for students, Concordia and the community at large along with our indepth grassroots knowledge and collaboration with the resources available to students at the CSU, Concordia University and Concordia Community.

Kayle supervises the volunteer law students and meets with our student clientele Monday-Thursday. In her own law practice, Kayle assists clients with temporary and permanent immigration, asylum claims, and joint applications for divorce. This knowledge assists our volunteer law students in providing accurate and in-depth legal information to provide to our student clientele. Kayle is also an active member of the Montreal community, dedicating 8 years of pro-bono support to Pinay, the Filipino Women's Organization.

Hannah supervises the volunteer law students and meets with our student clientele every Friday. In her own practice, Hannah works with DTMF-RHFW to promote and defend the fundamental rights of household and farm workers in Quebec and Canada, in particular those with precarious immigration status. Hannah's advocacy work empowers not only our staff but our student-clientele. Hannah is an active member of the Montreal community, dedicating 4 years to Pinay as well. This organization empowers migrant and immigrant women to assert their rights and fight for their basic rights and welfare.

Volunteer Law Students

Volunteer law students are available 20 hours per week! They provide you with information on the law, procedures and recourses. They can explain to you governmental forms and how to write a letter of demand (to request action from another person or company to address a problem). Legal Fee Funding Cases

Of the cases who benefited from the LIC Legal Fee Fund from May 2023 – April 2024, legal representation and fees were provided for 8 clients on the following subject matters:

1.Resolving precarious temporary immigration status and obtaining permanent residency for an Asian survivor of conjugal violence. 2.Same-sex sexual harassment at work. 3.Review of Concordia policies on sexual violence following a lawsuit by a survivor of sexual violence on campus. 4.Civil lawsuit against the City of Montreal for police brutality and racism towards a Black student despite Quebec Human Rights Commission's refusal to proceed.

Appointments, Research and Case Management

Due to the complexity of cases, many students require more than one appointment to deal with their issue. From May 2023 to April 2024, the LIC handled a total of 227 appointments, lasting on average 1 hour each.

For each case, apart from the time spent on a case during appointments, at least an additional 2-4 hours is spent by the volunteer law students and supervising lawyers on legal information research, case management and communications with the students.
